The Superintendent Maintenance Auxiliary Services is responsible for maintenance of the plant machineries by ensuring the availability and reliability of the equipment including compliance to legislation governing the mine.

## Key responsibilities will include:

- Ensuring safe installation, operation and maintenance of the equipment with regards to planning, leading, organising, controlling and increased reliability of the equipment through cost analysis.
- Implementing and executing maintenance strategies to ensure availability of the equipment.
- Performing preventative maintenance using condition monitoring techniques for component repairs.
- Ensuring critical spares availability.
- Ensuring rapid response to breakdowns.
- Ensuring that all safety appliances, mechanisms and guards are maintained in good condition.
- Ensuring legal compliance of equipment especially TMM, Lifting Equipment, pressure vessels to the relevant safety standards.
- Ensuring compliance to training requirements for the employees and contractors.
- Ensuring all work performed by contractors comply with MHSA, company policies and standards.
- Performing SHEQ audits and inspections to ensure compliance.
- Accountable for the comprehensive cost control and budgetary requirements.
- Supervising, co-ordinating and controlling the activities of multi-disciplinary team to ensure optimization of human resources.
- Coaching, developing performance agreements for subordinates, evaluating subordinates against performance agreement standards and develop career development plans based on performance evaluation.
- Identifying training needs and ensure appropriate training is conducted (formalized and on-thejob).
- Monitoring subordinates and initiate disciplinary action where required.
